


Prime Time collects the social security numbers of individuals who are incentive applicants. The social security number is required to issue incentive recipients IRS 1099-MISC forms at the end of the year as mandated by current tax law.* Please note that Prime Time takes your privacy very seriously, and we have multiple precautions, protocols, and processes in place to ensure that your confidential information is properly maintained and safeguarded.

You are only required to complete a new W-9 form if your name or address has changed since you last submitted it. If you are unsure if something has changed, please submit a new one.

W-9 Instructions:

- Download the [W-9 form](#) (next page)
- **Type in the fields highlighted yellow** or print and handwrite **(the signature and date fields must be handwritten)**
- Include your name (as shown on your income tax return), personal mailing address, social security number
-  Print and include your **handwritten signature and today's date**
- Scan or take a clear picture

**You will only be issued a 1099-MISC form from Prime Time if you received \$600.00 or more in incentives during the year. Prime Time will not send you a MISC-1099 form if you were issued a PayPal incentive. The threshold for reporting revenue from Paypal is 200 transactions per individual person or \$20,000 in payments. PayPal is responsible for sending you a MISC-1099 form if you have reached that threshold.*

DON'T include your employer identification number (EIN) instead of your social security number (SSN). Prime Time can issue a check to a place of business; however, we cannot dictate how the company will then distribute the funds. If this incentive check is being cut directly to you, the individual, your social security number is required.

Part I Taxpayer Identification Number (TIN)

Enter your TIN in the appropriate box. The TIN provided must match the name given on line 1 to avoid backup withholding. For individuals, this is generally your social security number (SSN). However, for a resident alien, sole proprietor, or disregarded entity, see the instructions for Part I, later. For other entities, it is your employer identification number (EIN). If you do not have a number, see *How to get a TIN*, later.

Note: If the account is in more than one name, see the instructions for line 1. Also see *What Name and Number To Give the Requester* for guidelines on whose number to enter.

Part II Certification

Under penalties of perjury, I certify that:

1. The number shown on this form is my correct taxpayer identification number (or I am waiting for a number to be issued to me); and
2. I am not subject to backup withholding because: (a) I am exempt from backup withholding, or (b) I have not been notified by the Internal Revenue Service (IRS) that I am subject to backup withholding as a result of a failure to report all interest or dividends, or (c) the IRS has notified me that I am no longer subject to backup withholding; and
3. I am a U.S. citizen or other U.S. person (defined below); and
4. The FATCA code(s) entered on this form (if any) indicating that I am exempt from FATCA reporting is correct.

Certification instructions. You must cross out item 2 above if you have been notified by the IRS that you are currently subject to backup withholding because you have failed to report all interest and dividends on your tax return. For real estate transactions, item 2 does not apply. For mortgage interest paid, acquisition or abandonment of secured property, cancellation of debt, contributions to an individual retirement arrangement (IRA), and generally, payments other than interest and dividends, you are not required to sign the certification, but you must provide your correct TIN. General Instructions

Section references are to the Internal Revenue Code unless otherwise noted.

Future developments. For the latest information about developments related to Form W-9 and its instructions, such as legislation enacted after they were published, go to www.irs.gov/FormW9.

Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

- Form 1099-INT (interest earned or paid)

- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)
- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
- Form 1099-C (canceled debt)
- Form 1099-A (acquisition or abandonment of secured property)

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.

If you do not return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See What is backup withholding, later.
